 - (c) The label shall be printed and affixed on the Openwell Submersible Pump Set at the cost of the permittee.

 - (e) The permittee shall pay the labelling fee of 10.00 (Rupees Ten) for Openwell Submersible Pump Set.
 - (f) The permittee shall furnish (through Standards & Labelling online web- portal) to the Bureau a statement containing details of production of labelled equipment and the accrued labelling fee due for each quarter within the following month of the close of each quarter of the financial year.
 - (g) The permittee shall make available such other details of Submersible Pump sets as and when sought by the Bureau for which the permission has been granted.
3. This permission shall be valid from **18th June, 2022 to 31st January, 2023** and may be renewed as prescribed. The permittee shall not withdraw the Submersible Pump sets from the market during the validity period of permission except with the prior approval of the Bureau.
